Briefly, what recent programs/services have been successful? Which need work? Explain. The Children's Center includes programming that blends the home and school connection. These events allow parents to be active in the classrooms several times per year and to celebrate their involvement in our program. University Advancement Fees allow for the hiring of 55 student worker teaching assistants each semester as well as providing discounts for 71 student-headed families.

What do you see as your department's financial priorities in the next 3 – 5 years (FY17-FY21)? The Children's Center is greatly in need of expansion, as the waiting lists reveal that many families are not able to secure a slot at the center for their young child. The average wait time for older children is about 6 months, however, the wait times are longer for parents with very young children. A program review by outside consultants in 2014 revealed that the center requires additional space for infants and toddlers as well as additional full-time assistant teaching positions.
